Ms. Vickrey previously practiced at the Illinois Attorney General's Office, where she worked as an Assistant Attorney General in the Labor & Employment Division of the General Law Bureau, handling civil rights employment cases in federal court. Prior to that, she worked at a boutique litigation firm where she practiced commercial and municipal civil rights litigation.

Ms. Vickrey has always carved out time for politics, pro bono work and mentoring younger lawyers. In 2015, she ran for Alderman of Chicago's 43rd Ward, advancing to a runoff and earning the endorsements of many elected city officials. In 2017, she won a first-degree, double jury murder trial in the Cook County Criminal Division on behalf of a pro bono client. She also serves as a mentor at Johnson & Bell, has served as an Adjunct Professor at DePaul University School of Law, and is a member of the 43rd Ward Judicial Review Board, interviewing and recommending judicial candidates for Illinois Circuit, Appellate and Supreme Court vacancies.
