

He has utilized bacterial genomic sequencing to defend foodborne outbreak litigation, and uses human genome sequencing to establish alternative causation and dispel notions of genetic susceptibility. In addition, he has researched, collaborated, and presented on the use of sequencing in the areas of toxicogenomics and pharmacogenomics, as well as the effects of genomic sequencing on the standard of care for medical providers.

He works on litigation as both local and national counsel and coordinates scheduling, discovery and trial work with national and local counsels, respectively.
